Auditor carries 2 tracts: 81.786 ac and .39 ac.

Deed 98-3 calls for 90 ac on the E side of the SE  $\frac{1}{4}$  of Sec. 26. It also calls for a tract to be leased out of the 90 ac as follows: tract leased to Church of God equaling 63 rods out of the SE corner not included in this conveyance and rights of the church are reserved, but no more than that right is reserved, and is included in the above 90 ac, except as to the rights of the Church of God.

The .39 ac tract carried as tract 2 is probably the same as the 63 rods parcel and the land was never excepted out of the 90 ac (only the rights of the Church were excepted) Therefore, the .39 ac is not carried as a separate parcel on the map.
