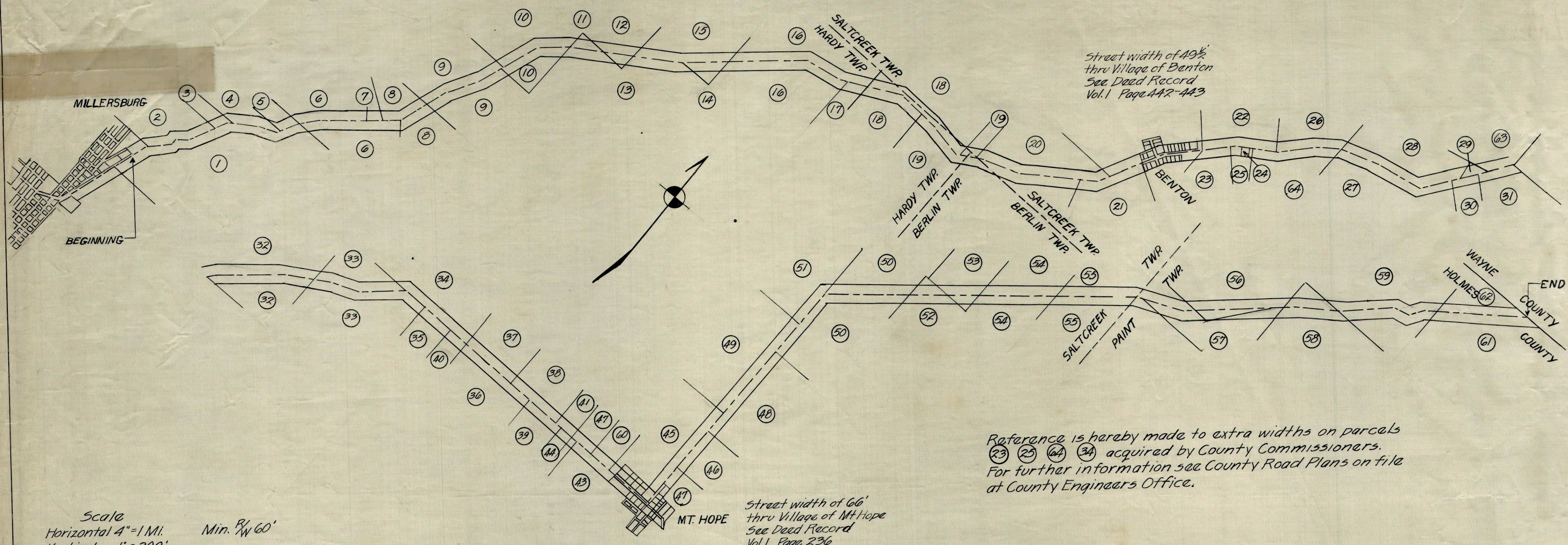


DEDICATION PLAT OF MILLERSBURG - MASSILLON ROAD
