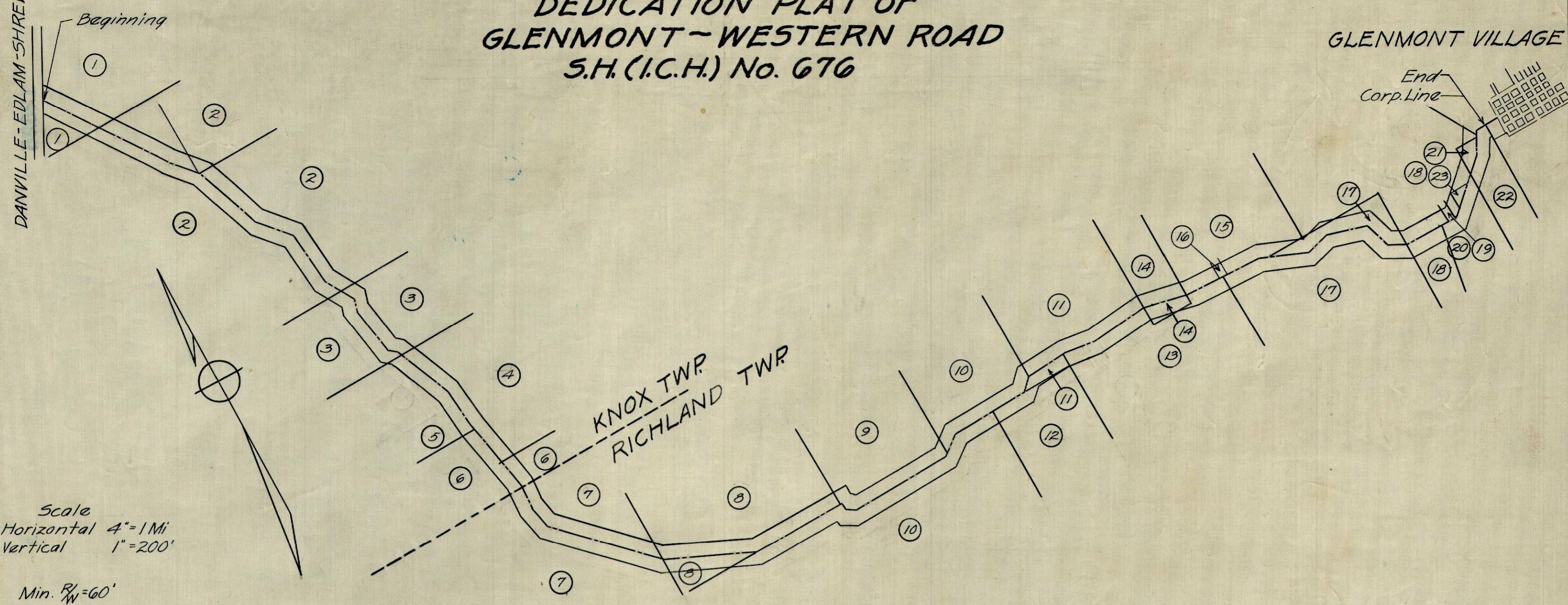


# HOLMES COUNTY DEDICATION PLAT OF GLENMONT-WESTERN ROAD S.H. (I.C.H.) No. 676
