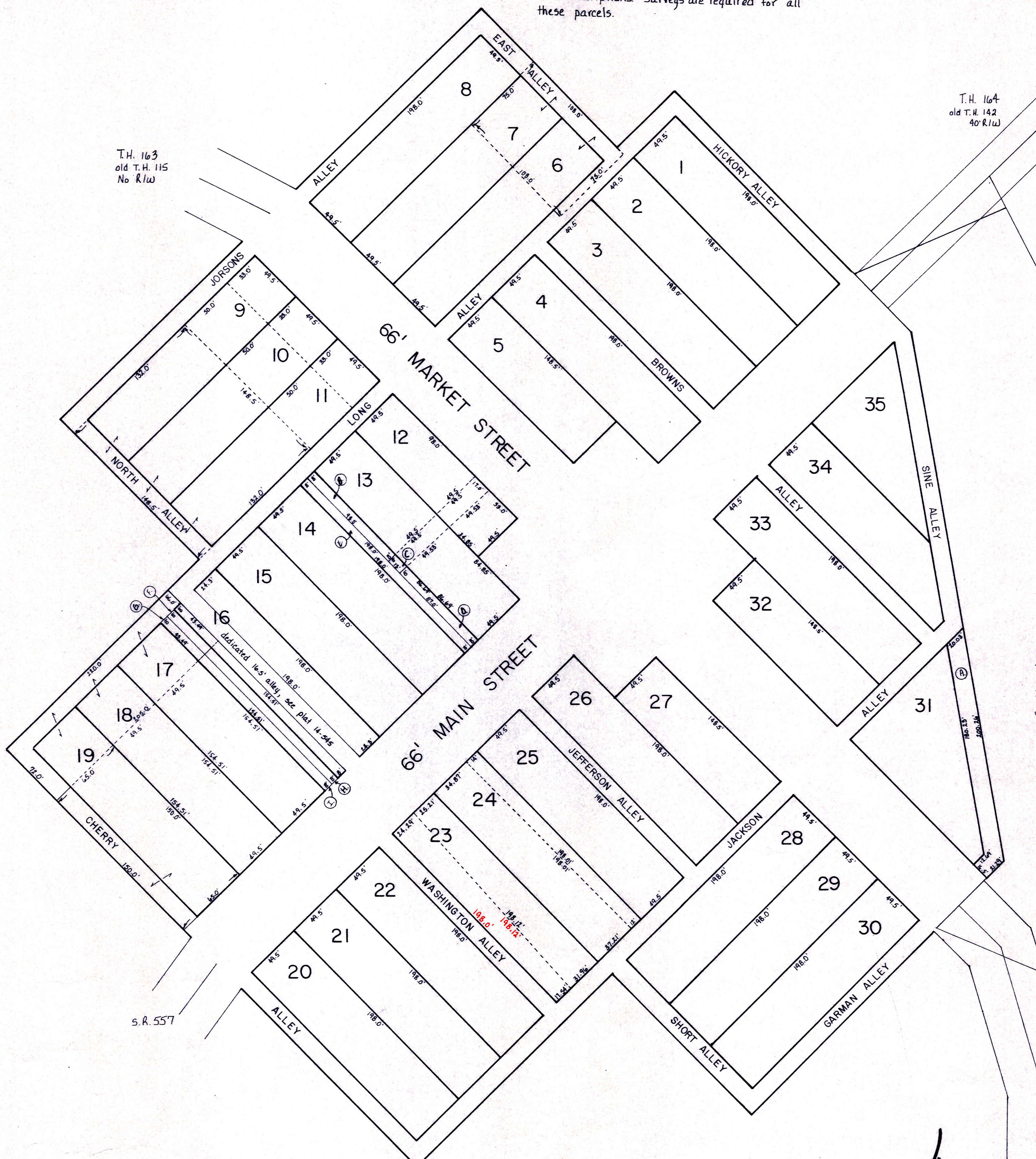


Village of Farmerstown

Alleys are 16.5' wide. Some alleys are not vacated on record, but nonetheless are covered by current deed descriptions. Surveys are required for all these parcels.

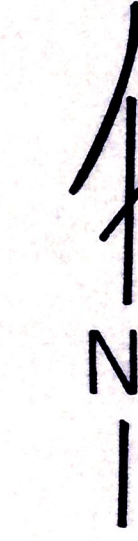
