

Description 0.428 acre parcel

Being a part of the southeast quarter of Section 6, Berlin Township, T-9 N, R-5 W, Holmes County, Ohio, also known as a part of the lands conveyed to Jason J. Raber and Melissa D. Raber in Official Record vol. 259 page 1734, PN 0100585000.

Described as follows:

Commencing at a 5/8 inch rebar found marking the northeast corner of the southeast quarter of Section 6, thence S 01 degrees 10' 20" W 741.90 feet along the section line to a point in C.R. 77, thence S 86 degrees 46' 11" W 91.86 feet along Holmes County Commissioners (O.R. 197 page 1999) north line to a 5/8 inch rebar found the TRUE POINT OF BEGINNING.

thence with the following SEVEN (7) COURSES:

- 1) S 04 degrees 31' 22" E 42.95 feet along said Holmes County Commissioners' west line to a 5/8 inch rebar found;
- 2) S 76 degrees 40' 19" E 35.00 feet along said Holmes County Commissioners' south line to a 5/8 inch rebar found;
- 3) S 05 degrees 51' 57" E 88.76 feet along said Holmes County Commissioners' west line to a point;
- 4) S 00 degrees 49' 34" W 11.15 feet along said Holmes County Commissioners' west line to a 5/8 inch rebar found;
- 5) S 86 degrees 44' 01" W 140.30 feet along Joseph A. Raber and Katie Raber's (D.V. 277 page 466) north line to a 5/8 inch rebar found;
- 6) N 01 degrees 07' 35" E 153.23 feet along Ivan E. Hostetler and Viola J. Hostetler's (O.R. 197 page 2232) east line to a 5/8 inch rebar found on Daniel C. Kauffman and Sarah Kauffman's (O.R. 22 page 470) south line;
- 7) N 86 degrees 46' 11" E 90.85 feet along said Kauffman's south line to the TRUE POINT OF BEGINNING.

This parcel is subject to an existing easement recorded in Deed vol. 262 page 193 and Plat vol. 14 page 352.
