DESCRIPTION OF AN 8.803 ACRE PARCEL

Situated in the Township Clark, County of Holmes and State of Ohio and also being part of the Southwest Quarter of Section 25, Township 8, Range 4 and being part of a parcel conveyed to Reuben D. Erb & Leanna R. Erb (P.N. 03-00029.009) and recorded in O.R. Volume 270, Page 2804 of the Holmes County Official Records, and more fully bounded and described as follows:

Beginning at a stone found at the northwest corner of said Southwest Quarter of Section 25, said point being the **Place of Beginning** for the parcel of land herein described;

Course No. 1; Thence S 88°55'03" E, along a northerly line of said Southwest Quarter of Section 25; a distance of 532.28 feet to a "Raw" iron pin found;

Course No. 2; Thence S 01°38'01" W, along a westerly line of a parcel of land conveyed to Eddie Troyer & Yvonne Troyer (P.N. 03-00029.008) as recorded in O.R. Volume 270, Page 3385 of the Holmes County Official Records, a distance of 518.23 feet to an iron pin set;

Course No. 3; Thence S 89°52'16" W, along a new line of division, a distance of 137.16 feet to an iron pin set;

Course No. 4; Thence S 47°19'24" W, along a new line of division, a distance of 387.56 feet to an iron pin set;

Course No. 5; Thence S 02°19'24" W, along new line of division, a distance of 231.77 feet to an iron pin set;

Course No. 6; Thence S 01°39'10" W, along new line of division, passing an iron pin set at 370.95 feet, a total distance of 386.41 feet to a point in the centerline of Township Road 175 (30 feet wide right-of-way);

Course No. 7; Thence S 77°34'53" W, along said centerline of Township Road 175, a distance of 4.34 feet to a point;

Course No. 8; Thence S 73°45'58" W, along the centerline of said Township Road 175, a distance of 48.12 feet to a point;

Course No. 9; Thence N 01°39'10" E, along new line of division and along an easterly line of a parcel of land conveyed to Crosspointe Mennonite Church (P.N. 03-00050.000) as recorded in O.R. Volume 253, Page 4143 of the Holmes County Official Records, passing an iron set at 15.76 feet and passing "RAW" iron pin found at 145.54 feet, a total distance of 402.54 feet to a 5/8 inch iron pin found;

Course No. 10; Thence N 02°19'24" E, along an easterly line of a parcel of land conveyed to Crosspointe Mennonite Church (P.N. 03-00029.007) as recorded in O.R. Volume 270, Page 19 of the Holmes County Official Records, a distance of 143.39 feet to a "Raw" iron pin found;

Course No. 11; Thence N 80°44'26" W, along a northerly line of said parcel of land conveyed to Crosspointe Mennonite Church, a distance of 68.28 feet to a "Raw" iron pin found;

Course No. 12; Thence N 01°39'10" E, along a westerly line of said Southwest Quarter of Section 25, a distance of 821.31 feet to a 5/8 inch iron pin found;

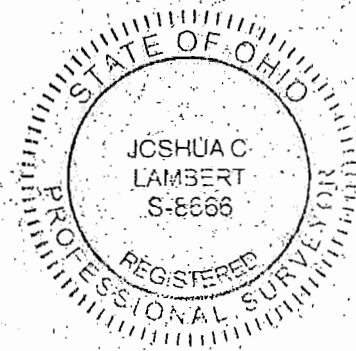
Course No. 13; Thence N 02°25'03" E, along a westerly line of said Southwest Quarter of Section 25, a distance of 45.76 feet to the **Place of Beginning**, and containing 8.803 acres of land, more or less, as surveyed by Joshua C. Lambert, P.S., Ohio Registration No. S-8666, for Diversified Engineering Inc., in January, 2020, but subject to all legal roads, highways, rights of way, easements and leases of record.

All iron-pins set are 30 inch X 3/4 inch round steel bars with plastic caps stamped "DIVERSIFIED ENGINEERING".
