

Description 5.500 acre parcel

Being a part of the northeast quarter of Section 24, Hardy Township, T-9 N, R-6 W, Holmes County, Ohio, also known as a part of the lands conveyed to Eugene R. Force in Deed vol. 265 page 851, and Deed vol. 267 page 213, and O.R. vol. 84 page 121, PN 0600094003.

Described as follows:

Commencing at a 5/8 inch rebar found marking the northeast corner of the northeast quarter of Section 24, S 01 degrees 22' 01" W 1076.89 feet along the section line and along the Berlin Township line to a R.R. spike found in the center of T.R. 309 the TRUE POINT OF BEGINNING, witnessed by a 5/8 inch rebar found S 01 degrees 22' 01" W 16.36 feet.

thence with the following NINE (9) COURSES:

- 1) S 01 degrees 22' 01" W 254.50 feet along the section line and along the Berlin Township line to a 5/8 inch rebar found;
- 2) N 88 degrees 00' 35" W 837.01 feet along Mary R. Raber, Trustee (O.R. vol. 157 page 75) and along Ervin A. Raber, Trustee's (O.R. vol. 157 page 79) north line to an iron pin set;
- 3) N 13 degrees 30' 30" E 471.28 feet through the lands of said Force to a point in the center of T.R. 309, witnessed by an iron pin set S 13 degrees 30' 30" W 27.47 feet;
- 4) S 60 degrees 11' 49" E 39.76 feet along the centerline of T.R. 309 to a R.R. spike found;
- 5) S 42 degrees 38' 19" E 191.13 feet along the centerline of T.R. 309 to a R.R. spike found;
- 6) S 69 degrees 21' 32" E 94.08 feet along the centerline of T.R. 309 to a R.R. spike found;
- 7) S 82 degrees 25' 13" E 225.97 feet along the centerline of T.R. 309 to a R.R. spike found;
- 8) S 87 degrees 30' 44" E 115.38 feet along the centerline of T.R. 309 to a R.R. spike found;
- 9) S 88 degrees 09' 30" E 141.29 feet along the centerline of T.R. 309 to the TRUE POINT OF BEGINNING.

This parcel contains 5.500 acres, but subject to all highways and easements of record.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker 6938". Bearings from Plat vol. 18 page 44.
