

Description 5.000 acre parcel

Being a part of the southeast quarter of Section 20, Mechanic Township, T-8 N, R-6 W, Holmes County, Ohio, also known as part of the lands conveyed to Eli J. S. Barkman and Esther S. Barkman in Official Record vol. 178 page 3011, PN 1200035000 and PN 1200024001.

Described as follows:

Commencing at an iron pin set marking the northwest corner of the southeast quarter of Section 20, thence S 85 degrees 40' 53" E 1989.26 feet along the quarter section line to a 5/8 inch rebar found, thence S 04 degrees 46' 14" W 402.05 feet along Freeman S. Raber and Martha Raber's (O.R. 186 page 3283 and O.R. 224 page 596) west line to a 1/2 inch pipe found the TRUE POINT OF BEGINNING.

thence with the following EIGHT (8) COURSES:

- 1) S 04 degrees 46' 14" W 545.27 feet along Aden A. Yoder and Ella M. Yoder's (O.R. 259 page 1622) west line to a 5/8 inch rebar found in the center of T.R. 117, witnessed by a 5/8 inch rebar found N 04 degrees 46' 14" E 12.74 feet;
- 2) S 77 degrees 32' 55" W 75.62 feet along the centerline of T.R. 117 to a 5/8 inch rebar found;
- 3) S 88 degrees 57' 25" W 226.46 feet along the centerline of T.R. 117 to a point;
- 4) N 88 degrees 52' 40" W 27.03 feet along the centerline of T.R. 117 to a point, witnessed by an iron pin set N 02 degrees 23' 11" W 11.81 feet;
- 5) N 02 degrees 23' 11" W 478.27 feet through the lands of said Barkman to an iron pin set;
- 6) S 87 degrees 28' 42" W 281.40 feet through the lands of said Barkman to an iron pin set;
- 7) N 03 degrees 07' 37" W 68.08 feet through the lands of said Barkman to an iron pin set;
- 8) N 87 degrees 28' 42" E 678.05 feet through the lands of said Barkman to the TRUE POINT OF BEGINNING.

This parcel contains 5.000 acres, but subject to all highways and easements of record.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker 6938". Bearings from Plat vol. 16 page 85.
