

Description 24.000 acre parcel

Being a part of Lot 15, Second Quarter, Mechanic Township, T-8 N, R-6 W, Holmes County, Ohio, also known as part of the lands conveyed to Paul W. Miller and Kimberly M. Miller in Official Record vol. 68 page 314, PN 1300299000.

Described as follows:

Commencing at a 5/8 inch rebar found at the intersection of T.R. 130 and T.R. 131 marking the northwest corner of Lot 15, thence S 01 degrees 42' 38" W 561.59 feet along the lot line and along T.R. 130 to a point the TRUE POINT OF BEGINNING, witnessed by an iron pin set S 87 degrees 20' 26" E 23.29 feet.

thence with the following NINE (9) COURSES:

- 1) S 87 degrees 20' 26" E 1759.46 feet through the lands of said Miller to an iron pin set;
- 2) S 01 degrees 42' 38" W 425.32 feet through the lands of said Miller to an iron pin set on Daniel E. Miller and Edna Miller's (D.V. 281 page 397) north line;
- 3) N 88 degrees 12' 55" W 394.84 feet along said Daniel E. Miller and Edna Miller's north line to an iron pin set;
- 4) S 75 degrees 52' 04" W 195.31 feet through the lands of said Paul W. Miller and Kimberly M. Miller to an iron pin set;
- 5) S 54 degrees 12' 09" W 313.94 feet through the lands of said Paul W. Miller and Kimberly M. Miller to an iron pin set;
- 6) S 77 degrees 19' 19" W 325.31 feet through the lands of said Paul W. Miller and Kimberly M. Miller to an iron pin set;
- 7) N 70 degrees 58' 48" W 531.75 feet through the lands of said Paul W. Miller and Kimberly M. Miller to an iron pin set;
- 8) N 68 degrees 29' 58" W 111.25 feet through the lands of said Paul W. Miller and Kimberly M. Miller to a point on the lot line and in T.R. 130, witnessed by an iron pin set S 68 degrees 29' 58" E 14.50 feet;
- 9) N 01 degrees 42' 38" E 583.38 feet along the lot line and along T.R. 130 to the TRUE POINT OF BEGINNING.

This parcel contains 24.000 acres, but subject to all highways and easements of record.

This parcel is subject to a 30 foot access easement for the purpose of ingress and egress, and further described as follows:

Being a part of Lot 15, Second Quarter, Mechanic Township, T-8 N, R-6 W, Holmes County, Ohio, also known as part of the lands conveyed to Paul W. Miller and Kimberly M. Miller in Official Record vol. 68 page 314, PN 1300299000.

Commencing at a 5/8 inch rebar found in T.R. 130 marking the southwest corner of Lot 15, thence N 01 degrees 42' 38" E 554.91 feet along the lot line and along T.R. 130 to a point the TRUE POINT OF BEGINNING.

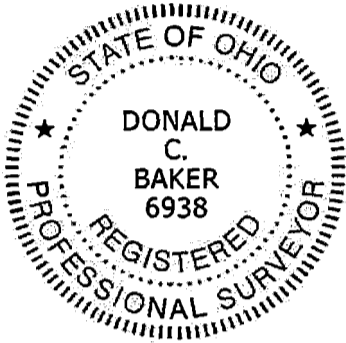
thence with the following TWO (2) COURSES along the centerline of a 30 foot access easement:

- 1) S 68 degrees 29' 58" E 115.92 feet through the lands of said Miller to a point;
- 2) S 18 degrees 42' 21" W 15.02 feet through the lands of said Miller to an iron pin set and THERE ENDS.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker 6938".
Basis of bearings assumed.
