

Description 7.330 acre parcel

Being a part of Fractional Section 3, T-14 N, R-11 W, Paint Township, Holmes County, Ohio, also known as part of the lands conveyed to Pauline R. Kasserman, Trustee in Official Record vol. 34 page 667, Official Record vol. 194 page 1951 and Official Record vol. 226 page 2361, PN 1500153000 and PN 1500154001.

Described as follows:

Commencing at a 5/8 inch rebar found marking the northwest corner of Fractional Section 3, thence S 89 degrees 36' 29" E 2623.18 feet along the section line to an iron pin set, thence S 00 degrees 14' 41" E 570.97 feet through the lands of said Kasserman to an iron pin set the TRUE POINT OF BEGINNING.

thence with the following TEN (10) COURSES:

- 1) N 73 degrees 03' 37" E 427.30 feet through the lands of said Kasserman to a point in a creek, witnessed by an iron pin set S 54 degrees 12' 46" E 54.90 feet;
- 2) S 54 degrees 12' 46" E 370.48 feet through the lands of said Kasserman to an iron pin set;
- 3) S 00 degrees 55' 35" E 124.08 feet through the lands of said Kasserman to an iron pin set;
- 4) S 78 degrees 09' 14" W 414.49 feet through the lands of said Kasserman to an iron pin set;
- 5) S 12 degrees 08' 15" E 383.22 feet through the lands of said Kasserman to a point in the center of T.R. 670, witnessed by an iron pin set N 12 degrees 08' 15" W 41.83 feet;
- 6) S 86 degrees 34' 44" W 51.11 feet along the centerline of T.R. 670 to a point, witnessed by an iron pin set N 15 degrees 21' 15" W 17.85 feet;
- 7) N 15 degrees 21' 15" W 296.81 feet through the lands of said Kasserman to an iron pin set;
- 8) S 82 degrees 13' 01" W 293.07 feet through the lands of said Kasserman to an iron pin set;
- 9) N 23 degrees 32' 19" W 338.68 feet through the lands of said Kasserman to an iron pin set;
- 10) N 54 degrees 11' 00" E 208.44 feet through the lands of said Kasserman to the TRUE POINT OF BEGINNING.

This parcel contains 7.330 acres, but subject to all highways and easements of record.


All iron pins set are 5/8 inch rebar with a plastic identification cap marked "Baker Surveying LLC".

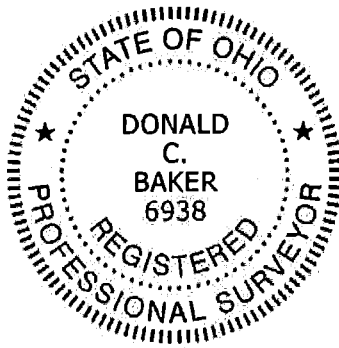
