- 3) THENCE South 21 deg. 46 min. 00 sec. East, 270.42 feet to a 1-inch mag nail (set) on the south line of the Southwest Quarter of Section 2, in State Route 754, at the southwest corner of said Holmes-Wayne Electric Cooperative, Inc. parcel, and a southeast corner of said Troyer parcel;
