

Auditor's Office Holmes County Ohio Millersburg November 13, 1893.

To the Master of the Annexation
of certain Territory to the incorporated

Village of Holmesville Holmes County Ohio.

Before the Board of Commissioners of Holmes County Ohio.

This Mastered this 13th day of November 1893 came on for further hearing
Pursuant to the order made by this Board September 6th 1893 with the full board
present and it being established to the satisfaction of this board for public hearing
by evidence that the incorporated Village of Holmesville Ohio through its
Council duly passed an ordinance by unanimous vote thereof authorizing
the annexation to said Village the territory in the petition described, that
said village by said ordinance authorized its solicitor to prosecute the proceedings
necessary to effect such annexation. That the petition herein was presented
to this Board at its regular September sessions 1893 and was duly filed in the
Office of the Auditor of said County that said petition sets forth that under said
Ordinance passed by said Village as above said the territory in said petition
described was authorized to be annexed to said Village, that the petition contains
an accurate description of said Territory that said petition is accompanied by an
accurate map or plan of said Territory, that said petition is signed by the persons
authorized by said ordinance to prosecute the proceedings for the annexation
of said Territory to said Village that Notices containing the substance of the
Petition and the time and place of this hearing was published in the Holmes
County Farmer a Newspaper printed and of a general circulation in said
Holmes County for a period of six consecutive weeks prior to this hearing and
concerning in the issue of said paper on the 21st day of September 1893, that
copies of said Notices were posted on each of the several tracts proposed to be
annexed to said Village on the 23rd day of September 1893, the same being no less
than six weeks prior to this hearing and that all necessary steps in this matter
had been properly taken and said Board of Commissioners coming now to
pass upon the merits of this Matter from the testimony find that the petition
contains all the matter required by the Statute in substance that the statements
of the petition are true that the limits of each of said tracts proposed to be
annexed to said village are accurately described and are not in either tract
unnecessarily large or small that the map or plan accompanying said petition
and bounding the two several tracts proposed to be annexed is accurate, that
the persons whose name is subscribed to said petition was duly authorized
in the premises by said village, that Notice has been given as required that
it is right and proper that the prayer of said petition be granted it is therefore
on this 13th day of November 1893 ordered by this Board that the territory
described in said petition be and the same is hereby annexed to said incorporated
Village of Holmesville and made thereof a part of said Village as prayed
for in the petition that the Auditor enter all the findings and orders made
by this Board in this matter upon the Journal and cause a transcript thereof
together with the petition and map to be forwarded to the Clerk of said
incorporated village
