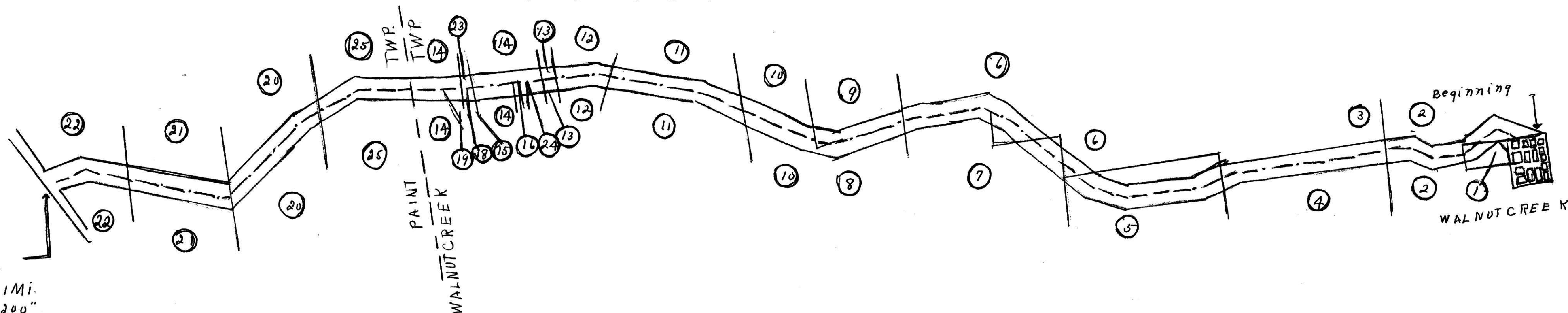


HOLMES COUNTY
