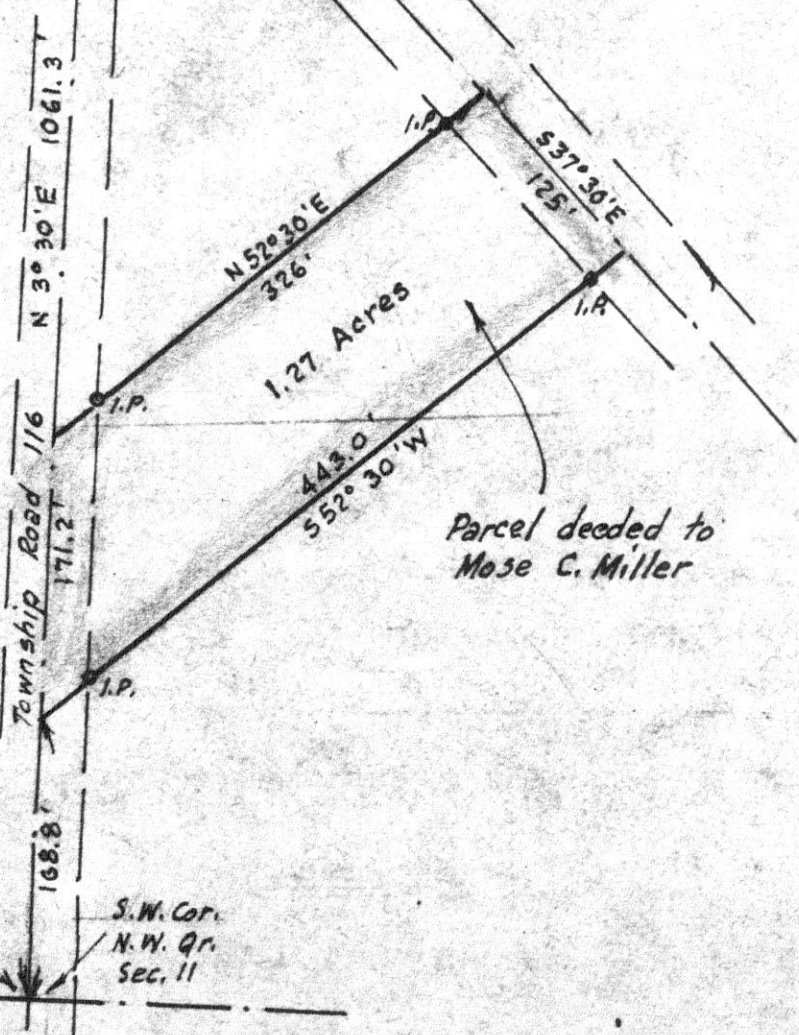

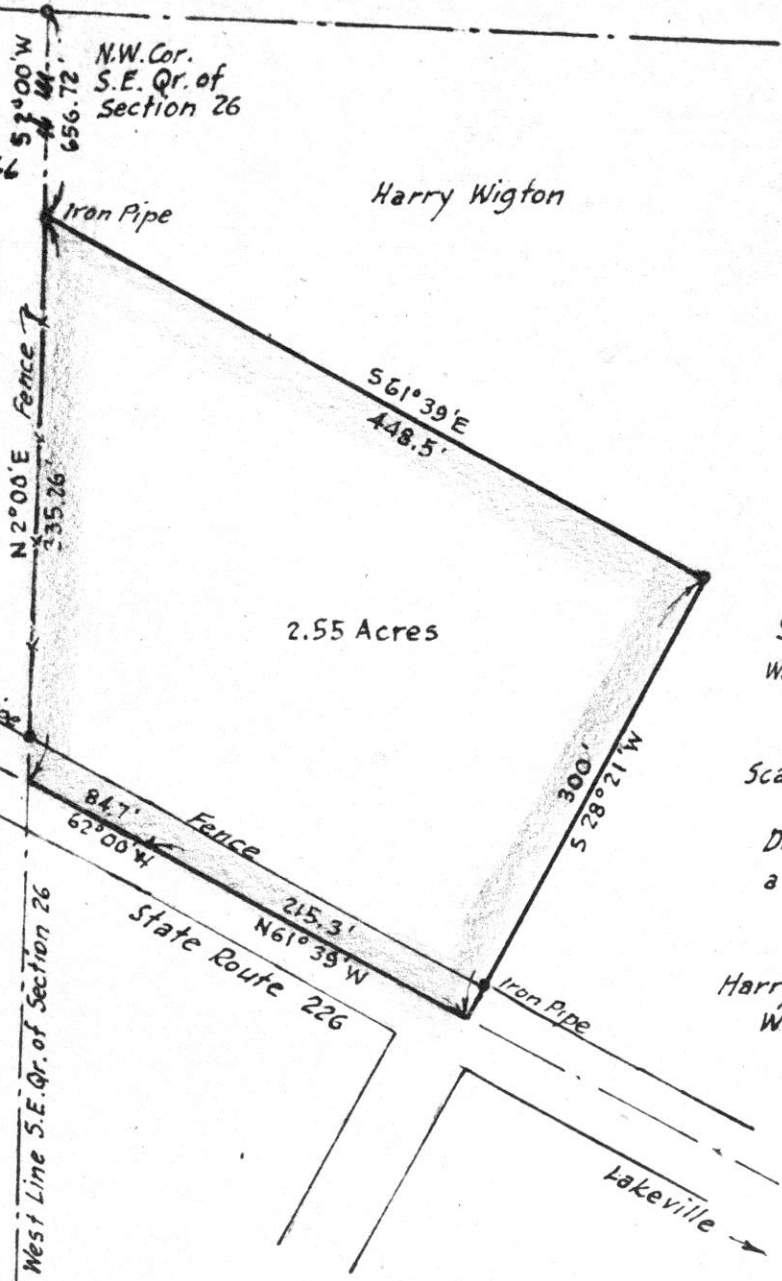

HARRY WIGTON

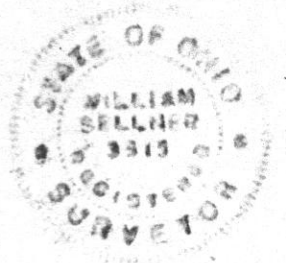

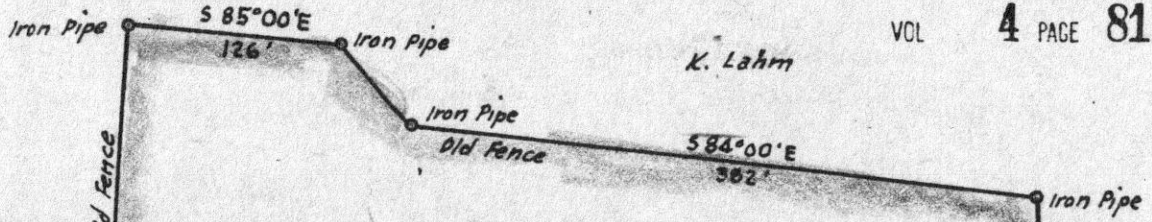

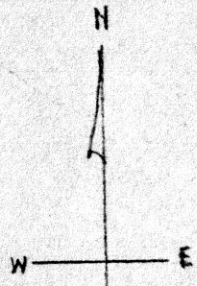
