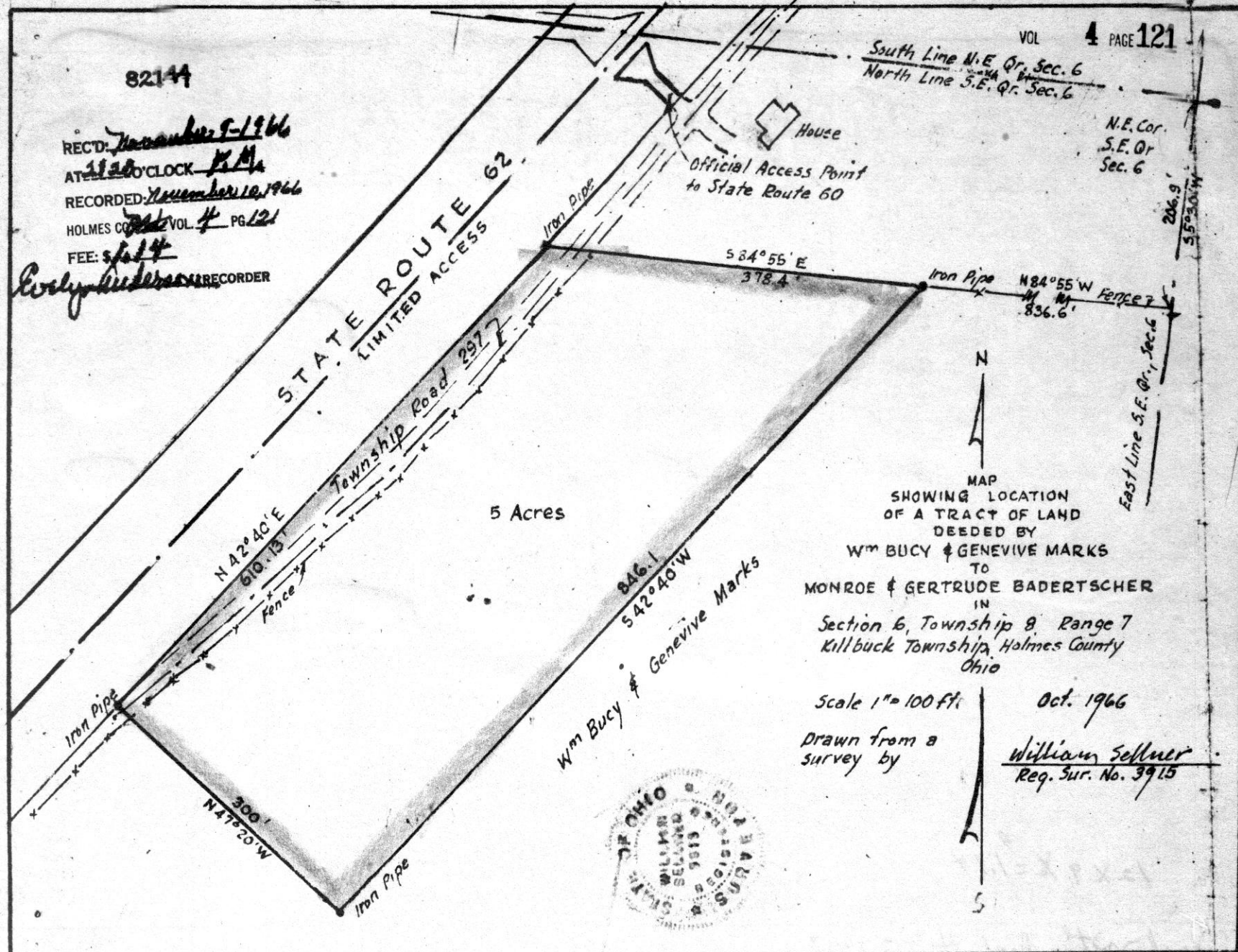

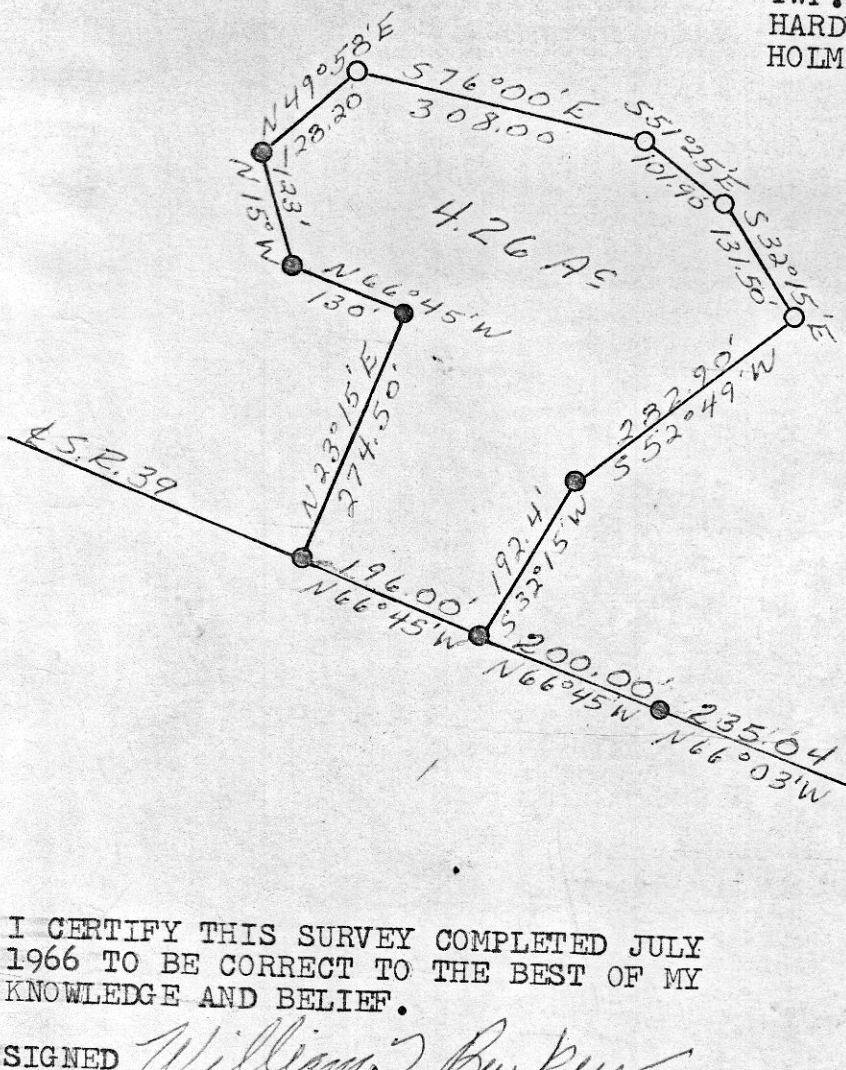

 HOLMES COUNTY, OHIO



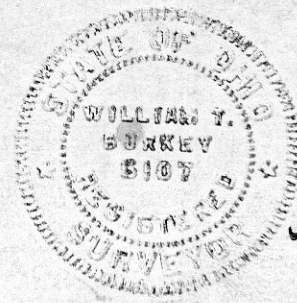

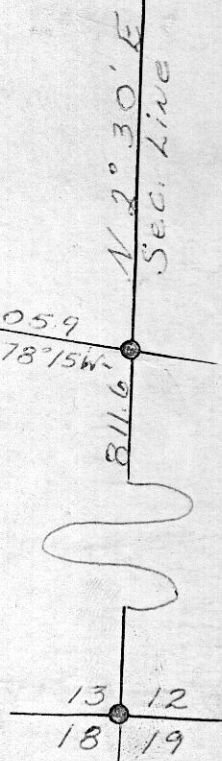

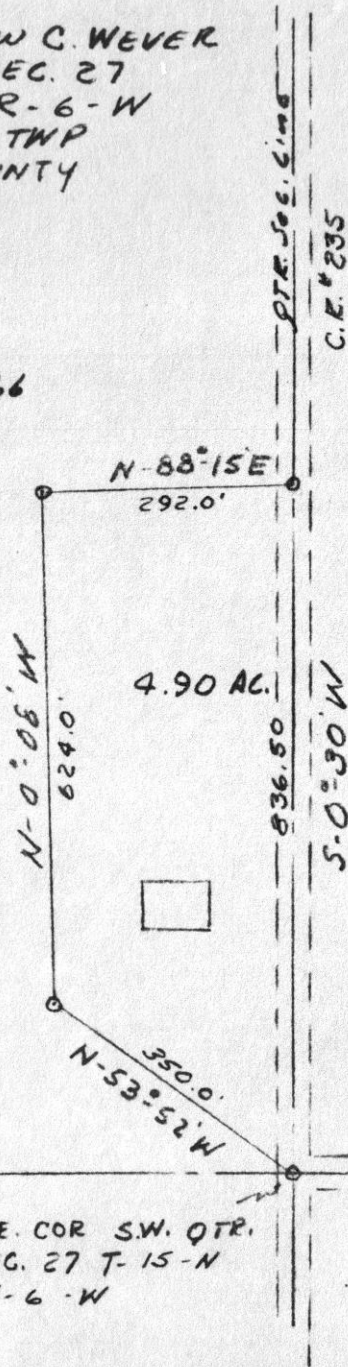
