ORDINANCE NO. 202

TO VACATE GENERAL TAYLOR STREET FROM THE SOUTH LINE OF MAIN STREET SOUTH TO A 12' ALLEY RUNNING EAST AND WEST TO VACATE SAID 12' ALLEY FROM VERMILLION STREET TO ERIE STREET IN THE VILLAGE OF HOLMESVILLE, OHIO.

Be it ordained by the council of the Village of Holmesville, Holmes County, Ohio,

SECTION 1: That whereas the Council is satisfied that good cause exists for vacating General Taylor Street from the South line of Main Street south to a 12' Alley running east and west and also to vacate said 12' alley from Vermillion Street to Erie Street as prayed for, that it will not be detrimental to the General interest and ought to be done;

And, whereas, the owners of all the properties abutting said street and alley have petitioned this council and consented to the vacation of said General Taylor Street and said alley;

Therefore be it ordained;

SECTION 2: That General Taylor Street be vacated from the south line of Main Street south to a 12' alley and that said 12' alley be vacated from Vermillion Street to Erie Street.

SECTION 3: That this ordinance be and remain in force from and after the earliest period allowed by law.
