

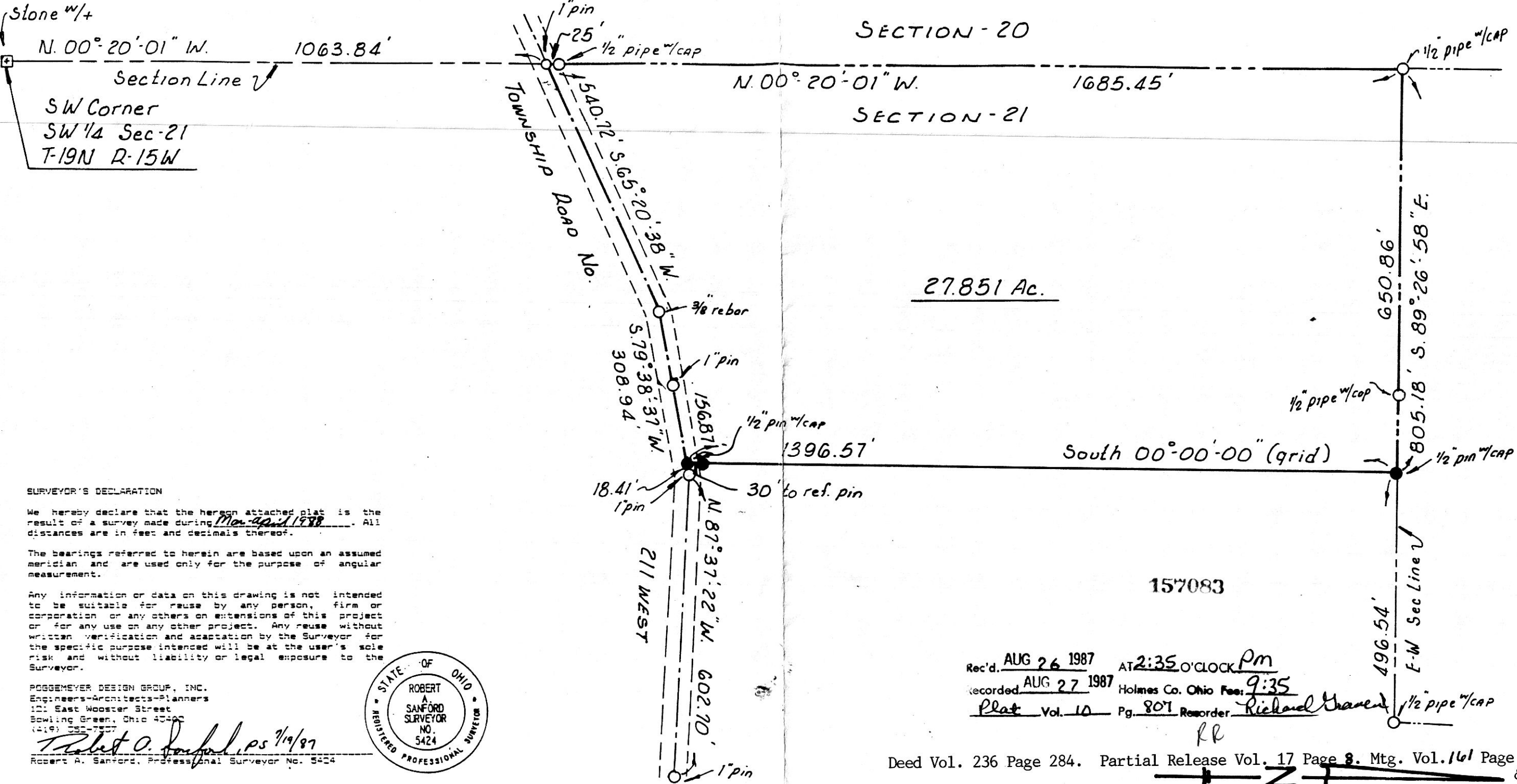

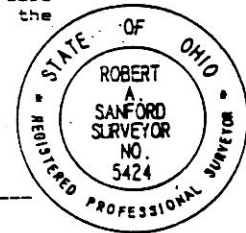
SURVEYOR'S DECLARATION

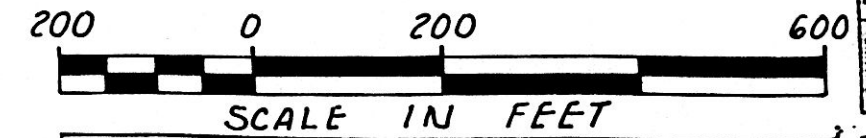
