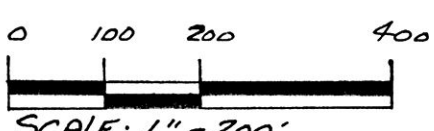


KILLBUCK TOWNSHIP

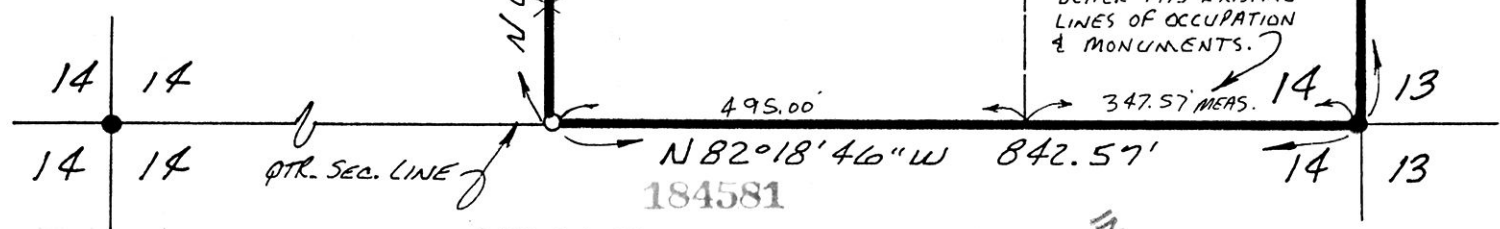
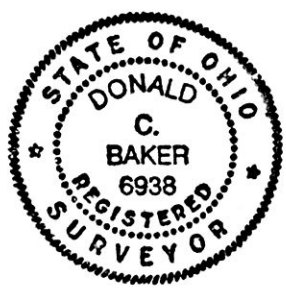
