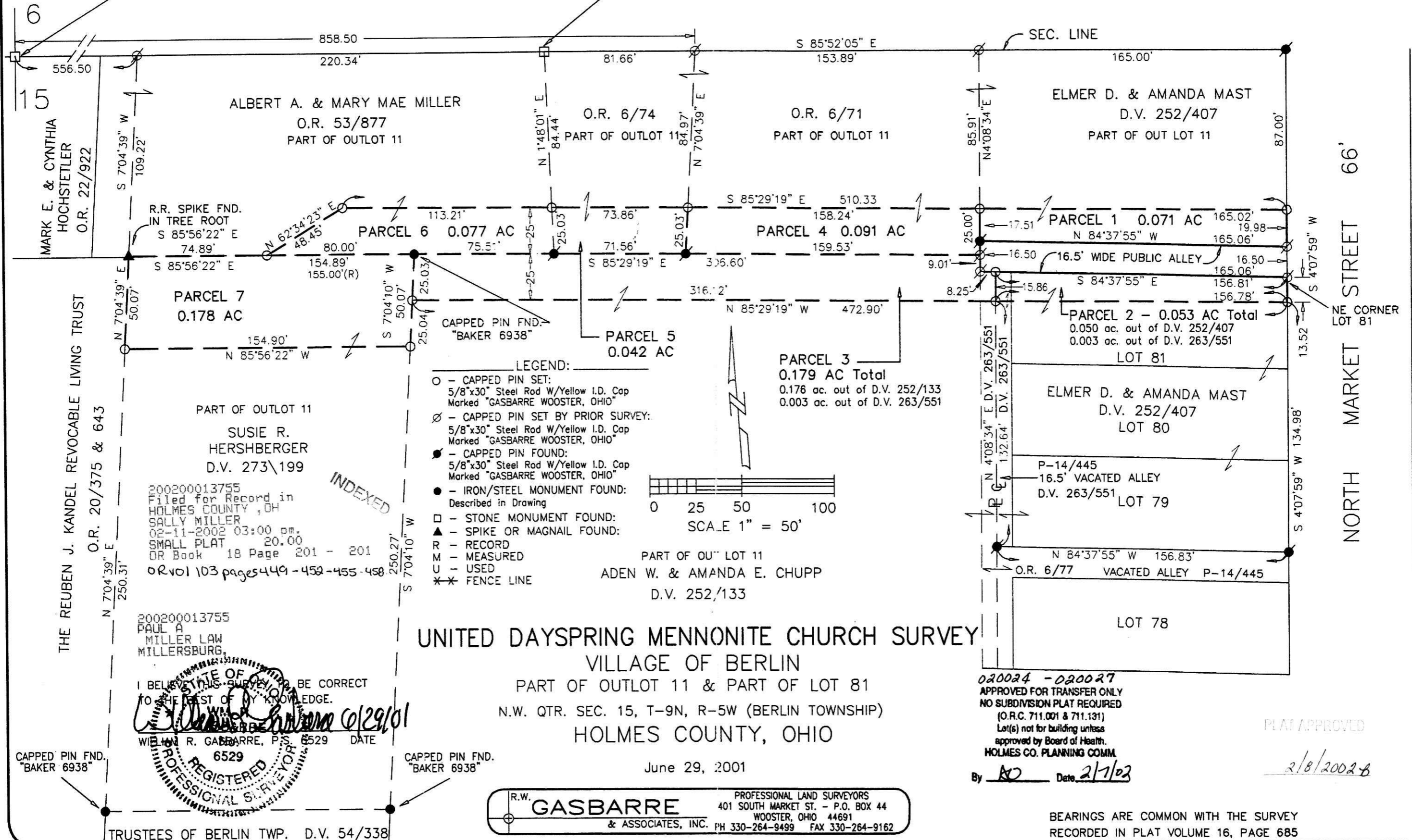


NW CORNER OUTLOT 11 FROM PRIOR SURVEY

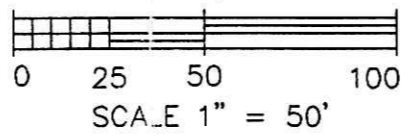
