The East & west line being parallel.

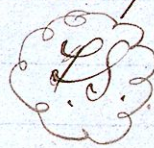

I hereby certify that, Harvey Close of Millersburg, Ohio, did on the 6th day of February A. D. 1909, lay out and plat what is known as Harvey Close, addition of inlots to the village of Millersburg, Ohio, the same being situated on Out-Lots of Beekets Addition of

Out-Lots To the Village of Millersburg, Ohio, and that said allotment and plat made by me was approved by the Council of Millersburg, Ohio, on March 3rd 1909, and recorded on the Plat-Record of Holmes County, Ohio, in Vol. 1. Pages 333 and 334

I hereby certify that such part of said allotment, as laid out and platted, laying and being west of the west-line of Walkup Street as shown by said Plat and being lots number 688, 689, 690, 691, 692, 693, 694, 695, 696, 697, 698, 699, 715, 716, 717, 718, 719, 720, 721, 722, 723, 724, 725, 726, 737, 738, 739 and 740 of the consecutive numbering of inlots, together with the streets and alleys shown on said Plat as laying and being west of the west-line of Walkup Street were incorrectly and erroneously laid out and platted and in part do not exist.

I also certify that I am the sole owner of all of the above lots; that none of said lots nor any part thereof have been sold. That none of the streets or alleys, nor any parts of said streets or alleys have been opened to the public by me nor the village of Millersburg, Ohio, that more than seven years have elapsed since said allotment was made and approved by the Council of the Village of Millersburg, Ohio.

I further certify that it is necessary and to the best interest and welfare of the village of Millersburg, Ohio, that said part of said allotment be vacated and reverted to out-lot.

Therefore be it known that I, Harvey Close, the sole owner of said part of said allotment do hereby, with the consent and approve of the Council of the Village of Millersburg, Ohio, set aside and vacate said part of said allotment as herein described and revert the said lands to Out-Lot number ~~44~~ ⁽⁴³⁾ from which it was taken; This vacation to be effective as soon as approved by the Council of the village of Millersburg, Ohio and recorded on the Plat-Record of Holmes County, Ohio
