Ordinance No. 98 - 110

An Ordinance Accepting Annexation on Application of Rodhe's Market, Inc. And Declaring An Emergency

Whereas Rodhe's Market, Inc. has petitioned the Board for the annexation of a parcel of property.

Section 1. The proposed annexation as applied for in the petition of Rodhe's Market, Inc., approved for annexation to the Village of Millersburg by the Board of Commissioners on June 22, 1998 is hereby accepted. The territory to be annexed is described as follows:

See Exhibit A attached hereto and incorporated herein by reference.

The certified transcript of the proceedings for annexation, with an accurate map of the territory, together with the petition for annexation and other papers relating to the proceedings of the County Commissioners, are on file with the Clerk of this Village.

Section 2. The Village Clerk is directed to make three (3) copies of this ordinance, to each of which shall be attached a copy of the map accompanying the petition for annexation, a copy of the transcript of proceedings of the Board of County Commissioners relating thereto, and a certificate as to the correctness thereof. The Clerk shall then forthwith deliver one copy to the County Auditor, one copy to the County Recorder and one copy to the Secretary of State, and shall file notice of this annexation with the Board of Elections within thirty days after it becomes effective, and the Clerk shall do all other things required by law.

Section 3. Be It Further Resolved that an Emergency exists to annex these parcels immediately so that Police, Fire, Rescue Squads and Village services may be provided to the territory subject to annexation.

For the reason stated immediately above this Ordinance is hereby declared to be an emergency measure necessary to the immediate preservation of the public health, peace, safety and welfare of the Village; wherefore, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor; provided it receives the affirmative vote of at least three-fourths of the members of Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law.



A RESOLUTION AUTHORIZING AND APPROVING ANNEXATION OF PROPERTY IN HARDY TOWNSHIP TO THE VILLAGE OF MILLERSBURG, OHIO

WHEREAS the Board of County Commissioners of Holmes County, Ohio, proceeding this twenty-second day of June, nineteen hundred and ninety-eight, having heard the petition signed by Kurt A. Rodhe, President and Agent for Rodhe's Market, Inc., for the annexation to the Village of Millersburg, Ohio, of certain territories described in the petition, and having at open meeting on June twenty-second, nineteen hundred and ninety-eight, heard all of the persons desiring to be heard for or against the granting of said petition and having considered the documents and all matters relative thereto which were presented to this Board, and being fully advised in all matters, does hereby find as follows:

- I. The petition contains all matters required by law, Section 709.02 of the Ohio Revised Code, namely:
 - A. A full description and accurate map of the territory sought to be annexed. (Exhibits A & B)
 - B. A statement of the total number of owners of real estate in the territory sought to be annexed.
- II. The matters alleged in the petition are true.
- III. Notice of the filing of said petition has been published as required by law, and notice was given to the Clerk of Hardy Township and the Clerk of the Village of Millersburg, Ohio.
- IV. The persons whose names are subscribed to the petition are owners of real estate located in the territories in the petition, and as of the time the petition was filed with the Board of County Commissioners the number of valid signatures on the petition constituted a majority of the owners of real estate in the territory proposed to be annexed. No signatures were removed from said petition.
- V. The Village of Millersburg has complied with division (B) of Section 709.031 of the Revised code of Ohio, by passing Resolution 98-17, INDICATING THE SERVICES THE VILLAGE OF MILLERSBURG WILL PROVIDE TO CERTAIN TERRITORIES PROPOSED FOR ANNEXATION UPON ANNEXATION (copy attached) and filed it with the Board of Commissioners of Holmes County, Ohio.
- VI. The territory to be annexed is not unreasonably large.
- VII. The territory is adjacent to the Village of Millersburg.
- VIII. The map and the description of the territories contained in the petition are accurate.
- IX. The general good of the territories sought to be annexed will be served if the annexation is granted.

THEREFORE, BE IT RESOLVED that it is hereby ordered that the prayer of the petition herein be granted and that the territory described in said petition may be annexed to the Village of Millersburg, Ohio, in accordance with law, and that a certified transcript signed by a majority of this Board of all the orders and proceedings of this board, relative to said petition and hearing thereon together with said petition and map attached thereto, and all the papers on file relating to said matter be deposited at once with the Clerk of the Village of Millersburg, Ohio.

RESOLUTION INDICATING THE SERVICES THE VILLAGE OF MILLERSBURG WILL PROVIDE TO CERTAIN TERRITORIES PROPOSED FOR ANNEXATION UPON ANNEXATION AND DECLARING AN EMERGENCY

WHEREAS, an Annexation Petition was filed with the Board of Commissioners of Holmes County, Ohio on April 20, 1998, requesting the annexation of two parcels of real estate consisting of 4.89 acres and 4.731 acres, more or less, to the Village of Millersburg; and,




