

Petition

The undersigned petitioner represents that the Council of the Incorporated Village of Millersburg, Holmes County, Ohio, did on the 5th day of April, A.D. 1909, at a regular meeting thereof, duly pass an ordinance authorizing that the contiguous territory hereinafter described be annexed to said Incorporated Village, and that the undersigned petitioner prosecute the necessary proceedings to effect the annexation of said territory to said Incorporated Village.

A copy of said ordinance containing an accurate description of said contiguous territory sought to be annexed is hereto attached and made a part of this petition, and marked Exhibit "A".

Your petitioner further represents that an accurate map of said contiguous territory accompanies this petition, is attached hereto and made a part hereof, and marked Exhibit "B".

Wherefore your petitioner prays on behalf of said Incorporated Village that you take such proceedings in the premises as will cause said territory herein described to be annexed to said Incorporated Village of Millersburg, Holmes County, Ohio.

Ordinance.

An ordinance authorizing the annexation of contiguous territory to the Incorporated Village of Millersburg, Holmes County, Ohio.

Sec: 1. Be it ordained by the Council of the Incorporated Village of Millersburg, Holmes County, Ohio that as the inhabitants of said Village generally desire to enlarge the incorporated limits of said Village by the annexation of the following contiguous territory, viz.: Lot No. 42, in the first-quarter Township of Township No. 9, of Range No 7, of the Connecticut Western Reserve School Lands containing about 80 acres, more or less, the same being in Hardy Township, Holmes County, Ohio, and being more fully described as follows; to wit: Beginning at the North West-corner of the territory now included in said Incorporated Village the same being the south west-corner of said Lot No. 42. thence in a Northerly direction along the east-bank of Killbuck Creek, and with the meanderings thereof; to the North west-corner of said Lot No. 42. thence South 87° 41' East, along the north line of said Lot No. 42 to the north east-corner thereof; thence South 2° 15' West to a stone on the north line of said Incorporated Village, the same being also the South east-corner of said Lot No. 42. thence North 87° 24' west along the south line of said Lot No. 42. and the North line of said Incorporated Village of Millersburg, to the east-bank of said Killbuck Creek, the place of beginning, said annexation is hereby authorized to be made, and E. J. Fisher, who is hereby appointed for the purpose, is hereby directed to prosecute the proceedings necessary to effect such annexation.

Sec: 11. This ordinance shall take effect and be in full force from and after its passage and due publication

Journal Entry.

This matter came on to be heard on the 9th day of August A. D. 1909, at One o'clock P. M. on the petition and application, accompanying plat and the evidence, in pursuance to the notice heretofore ordered to be given by this Board of Commissioners, at a regular session thereof, on the 7th day of June A. D. 1909, when said petition and application and accompanying plat were ordered filed, and upon consideration the Board of Commissioners find that notice of the time and place of the hearing of the petition and application herein were duly given as provided for by Law, by being published in the Holmes County Farmer, a paper printed in and of general circulation in said Holmes County, Ohio, for six consecutive weeks prior to this date, and that a copy of said notice was posted in a conspicuous place on the territory sought to be annexed herein for more than six weeks prior to this date.

The Board of Commissioners further finds, that the statements contained in the petition and application herein are true, that the Council of the Incorporated Village of Millersburg, Ohio, on the 5th day of April A. D. 1909, duly passed an ordinance authorizing the annexation of the territory in the petition, described, to said Village; that said territory is contiguous; that the petition contains an accurate description of said territory and is accompanied by an accurate plat of the same; that the petition was filed by the duly authorized agent of said Incorporated Village, and it seems right and proper that the prayer of said petition be granted.

It is therefore ordered that the territory described in said petition and application, to wit:

An Ordinance

Accepting the application for the annexation of certain contiguous territory to the Incorporated Village of Millersburg, Holmes County, Ohio.

Sec. 1. Be it ordained by the Council of the Incorporated Village of Millersburg, Holmes County, Ohio, that the territory described in an ordinance No. 353, passed April 5th 1909, and in a certain petition and accompanying map, filed with the Commissioners of Holmes County, Ohio, at their regular June 1909 session and proposed to be annexed to the said Incorporated Village of Millersburg, Ohio, be and the same is hereby accepted and said territory is hereby annexed to said Incorporated Village of Millersburg, Ohio, as is provided for by law in such cases, for all the uses and purposes of the said Incorporated Village of Millersburg Ohio.

Sec: II. That the Clerk of said Incorporated Village cause two copies of the petition, plat and transcript of the proceedings of the County Commissioners, and the ordinance in relation to said annexation together with his certificate to each that it is a true copy of the original thereof, and deliver one of said copies to the Recorder of Holmes County, Ohio, and forward the other copy thereof to the Secretary of State of the State of Ohio.

Sec: III. This ordinance shall be in full force and effect from and after its passage and due publication according to Law.
